#### Call

The joint annual meeting of Battlement Creek Village and Battlement Creek Village at the Reserve members was called to order at 7:04 pm by Laurel Koning, Battlement Creek Village Delegate and Jason Fletcher, The Reserve Delegate.

Mr. Rippy stated that the Board is discussing the issue.

Bruce Knuth asked what property did the BMSA purchase and where did the funds come from.

Delegate Koning explained that BMSA purchased 2.6 acres of property at 8935 County Road 300 in Parachute. The property was purchased through a bid process for \$45,000. The existing structures will be removed and the property will be cleared of all dead trees and brush in 2012. The Board of Directors is discussing potential improvements for the property. The money was taken from the reserve funds.

Bruce Knuth stated that there was a new covenant approved in 2012. The covenant is for vegetation extending into the streets and sidewalks. There are areas where this has become a hazard for traffic and pedestrians.

Bob Johnson stated that some of the blue bird houses throughout Battlement Mesa need to be rebuilt.

Sandy Getter explained that Gene Pickett takes care of the bird houses.

Delegate Fletcher stated that the BMSA Board of Directors meetings are the 3<sup>rd</sup> Tuesday of every month at 9:00 am at the BMAC.
