MANAGER REPORT - Update on Covenant Violation Action Item: Altitude Community Law officially sent a Demand Letter on August 30th, giving the homeowner 15 days from the date of the letter to cure the violation. The property owner has been cited for maintenance of property for months. The front yard has not been watered, mowed or maintained for a significant period of time. If the homeowner has not complied within the specified time frame; the Board needs to vote if they would like to take further legal action, under New Business.

Annual Village Meeting Dates: It's that time of year again when the Village Delegates need to set a date for their Annual Village Meeting during the month of October.

Butler Building/Red Roof Building: Parachute/Battlement Mesa Park and Recreation District (PBMPRD) has purchased the vacant commercial property that is located across the street from Alpine Bank, in partnership with Garfield County School District No. 16, with intentions to open an early childcare center. In your packet, is the Press Release that was given on September 5th.

<u>Tamarisk Meadows Straw Poll:</u> As approved at last month's Board of Directors meeting, a straw poll ballot, requesting input from Tamarisk Meadows owners, was mailed to all owners in the village, asking whether metal roofs should be allowed in their village. Included with the ballot, was a letter that contained the proposed architectural standards language that was previously adopted by the Board for Tamarisk Village and Monument Creek Village.

Trail Maintenance: A significant amount of tree and brush trimming was completed along the trail located behind The Willow Park and Willow Ridge Apartments. This section of the trail requires a great deal of maintenance due to the large elm trees growing adjacent to the trail. There are three large elm trees that have done significant damage to the asphalt trail from the root system. We did a major repair and repaved this section about 10 years ago. However, the root system of the three continues trees cause damage. I had the maintenance remove a medium size tree and many small trees growing next to the trail in order to prevent additional damage. The remaining large trees should be removed in order to properly repair the trail as well as prevent future damage to the trail section.
