#### COMMITTEE REPORTS

Finance Committee - Director Shepherd presented an overview of the BMSA financials for the month of November.

Architectural Committee - Assistant Manager, Vinnie Tomasulo, presented a report of member properties that had submitted architectural applications and the actions taken by the Committee in the month of November.

Covenant Control Committee - Assistant Manager, Vinnie Tomasulo, presented a report and list of community properties that had been issued a letter of violation of the covenants in the month of November.

Oil & Gas Committee - No report was given.

Associated Governments of Northwest Colorado - No report was given.

**Energy Advisory Board** – The EAB is now meeting quarterly.

MANAGER REPORT - Assistant Association Manager, Vinnie Tomasulo, gave an update on Manager Rippy.

BMSA office staff has extended an invitation to County Commissioner, Mike Samson, to attend a Battlement Service Association board meeting sometime in the first quarter of 2023 so the Board can ask questions and get updates regarding Garfield County issues. The BMSA office has not yet received a response.

Based on options presented by Assistant Manager, Vinnie Tomasulo, regarding investment of capital reserve funds, Director VanDeusen made a motion, seconded by Director Edwards to move funds into CDs with Edward Jones. The motion passed unanimously.

Assistant Association Manager, Vinnie Tomasulo, received a letter from Director Shepherd requesting that lighting on the Stone Ridge and Canyon View Village entrance signs be installed. Assistant Manager Tomasulo will meet with 360 Electric to assess what needs to be done. The Board members asked that all village entrance signs be assessed to make sure the lighting is working properly.

NEW BUSINESS - Director Haschke made a motion, seconded by Director Gates to become a 2023 Gold Level Sponsor for KSUN Community Radio (\$3,000). The motion passed unanimously.

The Board would like to see more advertising on the radio for BMSA. Administrative Assistant Morris will send a sign-up sheet to the Board, for Directors to volunteer to host a monthly segment.

Mary Lee Mohrlang and Brandi Swanson gave a presentation on the local zip code misidentification issue. Director VanDeusen made a motion, seconded by Director Mohrlang to approve Director Mohrlang writing a letter in support of the cause to give to Mrs. Mohrlang and Swanson. The motion passed unanimously.

Director Edwards made a motion, seconded by Director Gates to approve Resolution 2022-004 regarding voting by mail in lieu of a meeting for Delegate Area #7, Tamarisk Village. The motion passed unanimously.

Director Birrer made a motion, seconded by Director Reuter to approve Resolution 2022-005 regarding voting by mail in lieu of a meeting for Delegate Area #8, Tamarisk Meadows. The motion passed unanimously.

OLD BUSINESS - Director Edwards will update the Board on cost of brackets and installation of the CMC banners before the Board will move forward with a decision. The Board will discuss at next meeting.
