OWNERS OPEN FORUM -

CALL TO ORDER- President Haschke called the meeting to order at 9:00 a.m.

COMMITTEE REPORTS

Finance Committee - Director Shepherd presented an overview of the BMSA financials for the month of April.

Architectural Committee – Assistant Manager, Vinnie Tomasulo, presented a report on member properties that had submitted architectural applications and the actions taken by the Committee in the month of April.

Covenant Control Committee – Assistant Manager, Vinnie Tomasulo, presented a report and list of community properties that had been issued a letter of violation of the covenants in the month of April.

Associated Governments of Northwest Colorado - None.

Energy Advisory Board – Direct Arrington updated the Board on what was presented at the meeting.

MANAGER REPORT— Fence repairs have been occurring in the Tamarisk Meadows, Monument Creek and Willow Creek villages over the past several weeks. Strong winds damaged seven fence sections along Monument Trail in the Monument Creek village, two sections in Tamarisk Meadows and one section in willow Creek. This is the second spring in a row in which multiple sections of fence have been damaged by wind. Due to the large number of repairs, Manager Rippy anticipates that the maintenance costs will again exceed the budgeted amount for fence repairs.

The BMMD completed the sweeping of the 4-lane parkways and Stone Quarry for the county and has now begun street sweeping in the residential neighborhoods. Due to the amount of gravel laid on the streets through the winter months, it is anticipated the street sweeping will take several weeks to complete this year.

Lush Green Landscapes has begun right-of-way mowing along the parkways as well as the open space areas. The spring season always brings fast growth of the native grasses and weeds. Therefore, additional mowing will be required throughout the season and into the summer to try and keep up with the growth.

The audit of the 2022 BMSA financial records is nearly complete. The audit firm, McMann & Associates, has been working with BMSA Management and reviewing financial documents since the first of March. We anticipate that they will be preparing the preliminary 2022 audit report within the next few weeks.

Garfield County is currently crack sealing the Battlement Parkways, Sipprelle Drive and Spencer Parkway. They will also do crack seal on Stone Quarry Road. When they complete the crack seal, they will have a contractor chip and seal those streets.

NEW BUSINESS –

OLD BUSINESS – Marylee Mohrlang and Brandy Swanson provided additional information regarding the zip code issue in Battlement Mesa and the Town of Parachute. The United States Postal Service (USPS) responded in writing to the recent BMSA letter that appealed the denial for the request of a separate zip code for Battlement Mesa. The letter from the USPS confirmed that Battlement Mesa can be listed and associated with the 81635-zip code. Ms. Swanson stated that to change the name associated with the 81635-zip code for residents of Battlement Mesa, from Parachute to Battlement Mesa, requires approval from Garfield County. A letter on behalf of the BMSA requesting this change should be submitted to the County. It was suggested that all the BMSA Directors add their signature to the letter. The Directors agreed that all would sign the letter upon completion of an acceptable draft.
