OWNERS OPEN FORUM- Bonnie Smeltzer expressed concerns about the irrigation of the BMSA common area adjacent to Canyon View and the problems it creates for her home and three other homes. Ms. Smeltzer believes the area is watered to frequently and the excess water creates a problem for the four home owners. Mr. Rippy responded that the original irrigation systems installed, in many areas of the BMSA common areas, have too few irrigation zones requiring frequent watering in order to cover all the areas adequately. He went on to explain that consideration is being given to changing the areas to an attractive xeriscape in order to reduce the volume of water being used. Director Shepherd stated he would like to see a survey of Canyon View residents about xeriscaping to see how many residents support the alternative solution.

Karen Duncan wanted to the thank our maintenance person who repaired the fence in the Common Area; she stated that he did an excellent job.

Deborah Underwood asked some questions about repairing her shed and she was told she can go ahead and do the repairs. She also wanted to thank the BMSA Board and Mr. Rippy for keeping the weeds mowed down on the pathway.
