The **meeting** was called to order at 10:06am by Chuck Hall, President.

Chuck Hall introduced Dr. Steve McKee, District 16 Superintendent and Jim Cook, architect for the new Middle School. Dr. McKee and Jim Cook presented the plans for the new Middle School. A question and answer period followed their presentation.

APPROVAL OF MINUTES

A **motion** was duly made by Ray Barbour and seconded by Ron Schelling to approve the May 15, 2007 Board of Directors Meeting minutes as presented. **Passed.** Unanimous. A **motion** was duly made by Sue Lancaster and seconded by Ray Barbour to approve the June 5, 2007 Special Board of Directors Meeting minutes as presented. **Passed.** Unanimous.

MANAGERS REPORT

Jane Chapman submitted a written report. Ron Schelling noted the mowing has not been completed along Northstar Trail. Jane Chapman will check on the mowing progress. Jane Chapman also noted Tamarisk Village may not have low water pressure. In most instances, raising the sprinkler heads or alerting the homeowner to the height of their lawn resolves the issue. There has been no response from Grace Homes in regard to forwarding new Certificate of Occupancies to the Service Association for reference on Association issues.

Financial Report: A **motion** was duly made by Jay Haygood and seconded by John Shepherd to approve the May 2007 financial statements as presented, subject to audit. **Passed.** Unanimous.

Architectural Changes: A workshop is scheduled for Thursday, June 28, 2007 at 1:00 p.m. to finalize the architectural changes.

Street Sweeping: All Around Sweeping submitted a bid to finish sweeping the community. A **motion** was duly made by John Shepherd and seconded by Sue Lancaster to contact Flatiron Building Services requesting the original bid plus \$3,000.00 additional dollars be honored or all payment would be withheld. Jane Chapman noted Flatiron's revised proposal was equal to the proposal presented by All Around Sweeping and, due to Flatiron's quality of work, she recommended the Board consider having Flatiron finish the job. The previous motion was **withdrawn**. A **motion** was duly made by John Shepherd and seconded by Jay Haygood to pay Flatiron an additional \$7500.00 maximum subject to Jane Chapman negotiating for a lesser figure of \$5000.00 to \$6500.00. **Passed**.

Jay Haygood recommended the Street Sweeping Committee be reactivated to research the ownership of a street sweeper by the Service Association.

A **motion** was duly made by John Shepherd and seconded by Ron Schelling to have BMC mow the lots, post the charge to the owners account and send a billing statement with the noncompliance notice. **Passed.**

Dan Locker noted 56 West Bonanza Place is back in compliance as of this morning although Mr. Hoag has not notified the Association of his compliance.

Architectural Committee: A written report was submitted.

Oil & Gas Committee: Frances Rose noted the Committee will be meeting with Encana to finalize the Energy Golf Tournament scheduled for Friday, June 22, 2007.

Road Committee: Frank Lancaster submitted a written report. Garfield County has received no bids for the road work located from the waterfall to the I-70 interchange.
