Trail Overlay Proposals

Mr. Rippy presented 3 bid proposals by Frontier Paving, United Companies and Grand River Construction to overlay approximately 14,700 lineal feet of existing BMSA trails. The 3 bids were: Frontier Paving \$213,805, United Companies \$235,216 and Grand River Construction \$273,000.

A motion was made by Director Shepherd and seconded by Declarant Fletcher to hire Frontier Paving at a cost of \$213,805 to overlay the remainder of the trails. The motion carried unanimously.

LED Retrofits

A motion was made by Director Koning and seconded by Declarant Fletcher to replace the current street lights in residential areas to LED lights, not to exceed the remaining budgeted amount. The motion carried unanimously.

OLD BUSINESS

Discussion of hiring a planner

The discussion was deferred until next meeting.

Director McCurdy stated that the National Night Out is scheduled for August 6, 2013.

Director Lammey stated that BMSA will be having the theatre again this year.

Director Koning reported that there are two more movies this season for Movies Under the Stars. They will be held on July 19th and August 9th.

BMSA Financial Committee

July 16, 2013 Report on Financial Documents

The June 2013 financial documents have been submitted to the Financial Committee by our Property Manager. Copies have been included in your packets. These have been reviewed. The financial documents cover the sixth month of our financial year and appear complete and accurate and comply with accepted financial accounting standards. There are no entries that are unusual.

The year to date data reflects the actual revenues falling short of budget amounts by \$9363.47 (2% of revenues). Fortunately our expenses are under running the budget amounts by a significant amount (15.2%) leaving the association in a positive position.

There were a number of expense items that exceed budgeted amounts but there were also many that were under the budgeted amount. None of the over budgeted items are so significant to cause concern.







The Public and Community Relations Committee's efforts continue to be focused on the following long term goals.

- Maintain and update the new BattlementMesaColorado.com website and promote the site to the extent possible. Continue to explore additional opportunities to make the site more useful and interesting.
- In conjunction with the four Northwestern Colorado counties, cities and towns, develop and construct Gateway Interpretative signs for Battlement Mesa/Parachute.
- Develop and implement a marketing and promotional plan to showcase the positive lifestyle available by living in the Battlement Mesa Community.
- Continue to develop relations and interactions with the BMMD, Town of Parachute, Garfield County and State and Federal Government agencies and regulatory bodies for the betterment of the Battlement Mesa Community.

Current Focus

- Website. As time permitted, additional work was done on our website, www.BattlementMesaColorado.com. The website traffic continues to be strong. During June, there were 10,626 visits to the site, (up from 9,340 in May), 36,432 page views, (down slightly from 43,181 page views in May and a new record high of 1,867,738 hits during June 2013. (Definition of Hit: A hit represents a request to your web site for a file such as an image, a web page, or a CGI script. One web page may contain several related resources, and as a result, a visitor viewing one web page may trigger several hits.)
- Newsletter Our newsletter distribution list has grown slightly to 425. Please encourage people to sign up for this newsletter. (Top of the Home page of website). The June newsletter achieved an open rate of 42.7% (165 opens of 421 which were sent) and above the industry average. The July Newsletter will go out in the next day or two.
- <u>Showcase Positive Lifestyle</u> We are completing the final revisions on the upcoming 2013 Insiders' Guide and will go to press shortly.
- Facebook Our facebook "friend" list is at 111 of which only 28 (so far) say they "like us." If you have a facebook account, please join our friend list and, encourage others to do so.
- NWCCHT. The Northwest Colorado Cultural Heritage Tourism group met in Rifle on June 18th to begin work on our Gateway Interpretive Signs. We are nearly out of rack cards and more are being printed.

CALL TO ORDER & INTRODUCTIONS - Chairman Mike Samson called the meeting to order at 10:10 am. Introductions were as follows:

NEXT MEETING - The next board/member meeting will be July 18th in Steamboat Springs at the Olympian Hall, Howelsen Hill Ski Area training center.

MINUTES - Minutes of the May 9th meeting were presented. A motion was made by Jeff Eskelson to accept the minutes, and second was made by Tom Mathers. **Motion carried**.

BUDGET REPORT - The May 2013 financial reports were presented by Ava Bowles, with explanation of a few format changes. Scott McInnis expanded on some of the budget items, and request was made for a list at the next meeting of which cities have not paid 2013 dues. Doug Monger made the motion to approve the financials, second was made by Jeff Eskelson. **Motion carried**.

PROJECT & COMMITTEE REPORTS

Dinosaur Welcome Center (DWC): Manager Cheryl McDonald was not in attendance, but her written report showed May visitation up 6.7% over 2012, and looked forward to a June 18th study tour for her staff in Glenwood Springs.

Area Agency on Aging (AAoA): Director Dave Norman presented the Recommendations for the 2013-14 Area Plan on Aging for approval by the board, and then submittal by AGNC to the Colorado Department of Human Services. A funding letter from CDHS will allow AGNC to implement Older American Act & State Funding for Senior Services programs through the Mesa County Department of Human Services for our 5 northwest Colorado counties. Dave's handouts showed detail of the requested funds for the grant by category & provider, as well as the percentages of distribution & local share dues for each county. Tom Mathers made a motion to approve the budget, Jeff Eskelson seconded the motion. Motion carried.

Dave Norman also asked for a letter of support from AGNC for a grant request to the Colorado Health Foundation. The Western Colorado ARCH/211 organization is proposing combining existing functions to more efficiently deliver the same services, eliminating some of the issues with the single entry point system. Mesa County will be the \$1,733,417 grant applicant, and the board agreed to issuance of a letter.

Communications: Kelly Sloan, RightWord Consulting, outlined projects since the last meeting, including press releases expressing AGNC's disappointment in Governor Hickenlooper signing SB 25 and SB 252 despite strong opposition. Executive Director Scott McInnis gave some background on a forthcoming letter regarding the vacating of mineral leases on the Roan Plateau. He met with Doug Dennison, Bill Barrett Corp, and Marty Chazen, Grand Junction City Councilman, to discuss the possible repercussions to the cities that have received impact funds. An AGNC letter is being drafted to DOLA asking that northwest Colorado governments and jurisdictions be held harmless financially in the event that the leases are vacated. Scott also explained that letters drafted by Kelly are reviewed by the AGNC Executive Committee, and forwarded after approval. Upcoming projects include a media page on the AGNC website, and a resolution to support the Cameo site shooting range. Rich Sales, Palisade Town Administrator, gave an update of steps taken to gain support for the shooting range. Doug Monger made a motion to approve the resolution, with a second by Jeff Eskelson. Motion carried with one opposed.

OTHER – Notice was given of the Air Quality Control Commission Meeting June 20th & 21st in Grand Junction, where western Colorado air quality issues will be addressed.

MORNING SPEAKER - Randi Lowenthal, Roaring Fork Business Resource Center, shared the history & mission of the organization. It serves both as a virtual incubator that nurtures start-up enterprises, and a resource center that helps established businesses grow & prosper. Utilizing partnership with CMC, the center strives to educate businesses from Parachute to Aspen, and has allowed their blueprint to be used by other counties to benefit their programs as well. They also try to match up investors with businesses that need capital when banks are not the solution. Randi encouraged all to visit their website, and keep the center in mind as another tool to assist economic growth in the northwest Colorado area.

NOON SPEAKER – Kevin Tilson, Colorado Office of Economic Development and International Trade, traveled from Denver to give a presentation on how the Enterprise Zone works to encourage business to locate in northwest Colorado. As we are Administrator for the Northwest Zone, Kevin gave some history of how the program came into existence, as well as how the 10 types of tax credits can be utilized. The process to qualify has been simplified by digital reporting, but members were concerned that more needs to be done to let business know about the tax credits. (Kevin conducted a training session with new EZ administrator Ava Bowles after his presentation to the members.)

RIG TOUR – WPX hosted a tour of a natural gas drilling rig, allowing members & guests an opportunity to see the newest innovations in drilling.

ADJOURNMENT Chairman Mike Samson adjourned the meeting at 3:00 pm.

<u>Community Comprehensive Planning</u>: The Planning Committee met with Land Use Planner, Davis Farrar, to discuss and review the scope and process of creating a comprehensive planning document for the community. Don Gray, Jason Fletcher, Steve Rippy and Keith Lammey were present at the meeting. The consensus of the committee members was to recommend the Board of Directors move forward with a plan utilizing Mr. Farrar as the planner.

<u>Trail Overlays</u>: I met with three separate paving contractors to review the proposed trail overlays. I have received two bid proposals to date and should have the third by the July 16th Board of Directors meeting. I will discuss the bid proposals with the Board at the meeting to determine the next course of action.

<u>LED Installations</u>: The Willow Creek Village street lights were retrofitted with LED fixtures this past month. With the completion of the Reserve and Willow Creek and the installation of 10 LED fixtures last year a total of 48 street lights have been retrofitted. The cost per street for the Willow Creek and Reserve Villages was \$434 each. To date we have spent roughly \$17,000 of the \$100,000 that was budgeted for 2013.

Fire Mitigation: I met with Eric Short to review open space areas in the Willow Creek Village to assess additional fire mitigation work for this year. Eric and I will assess additional open space areas in the community including the Monument Creek, Stone Ridge and Saddleback. Much of the work will be conducted in the cooler fall months unless weather conditions allow sooner.

Right-of-Way Mowing: Baker & Associates completed the second mowing of the street right-of-ways.

8935 CR 300: The grading of the property has been completed and the erosion control has been installed on the property. The water service has been connected and temporary irrigation has been installed and hydro-seeding has been scheduled.
