# **OWNERS OPEN FORUM**

Doug Saxton talked about the approval process for the State for the URSA drilling and pipeline plan. Mr. Saxton stated that the Battlement Concerned Citizens successfully negotiated to have 26 conditions for drilling and 20 conditions for the pipeline added to the special use permit approved by Garfield County. Mr. Saxton is renewing his request that the BMSA ask our Local Government Designee to ask the COGCC to hold a hearing regarding the URSA drilling and pipeline plan and that hearing be held in Battlement Mesa. The request needs to be received during the open comment time of the process. The previous letter from the BMSA was sent prematurely.

Jay Haygood asked what the BMSA is going to do with the \$1,000,000 when it is received from URSA.

Director McCurdy stated that BMSA has not received any money at this time and there is no plan as to what the money would be used for.

Mr. Haygood stated that since it should be used for mitigation of industrial impacts, BMSA should install central air systems in homes that are within 150 feet of Stone Quarry Road

Director McCurdy stated that once money is received, BMSA will need to hold a meeting to discuss what the funds will be used for.

Bruce Knuth stated that he is not in favor of giving \$125,000 of the URSA money to Parachute/Battlement Mesa Park & Recreation District for the new park that is being built in Battlement Mesa. The park should be built by the developer since they will received the most benefit from it.

#### KIRBY WYNN-GARFIELD COUNTY OIL & GAS LIAISON

Kirby Wynn stated that his job is deal with issues effecting residents from the oil & gas development. Mr. Wynn stated that the Garfield County Commissioners are willing to come to Battlement Mesa at any time to discuss issues effecting residents. Mr. Wynn stated that URSA has sent their applications to the COGCC for approval. The open comment period began on January 6, 2016 and ends on February 16, 2016. If BMSA is going to request a hearing it needs to be submitted online by February 15, 2016. Mr. Wynn explained that the threshold to be granted a hearing is very high. The request needs to outline specific reasons for the hearing, the hearing will probably not be granted if it is just being requested for residents to be heard. Mr. Wynn stated that the Garfield County Commissioners did file a request today asking for the Colorado Department of Public Health be involved so they can monitor the health, safety and welfare of Battlement Mesa.

# January 19, 2016 Report on Financial Documents

# For December 2015

# **Operating Accounts**

This report is for the twelfth and the final month of our financial year. The bottom line for December 2015 continues positive. Copies of the December 2015 financial documents have been submitted to the Financial Committee and copies have been included in your packets. These have been reviewed and we find them in a complete and accurate but of course subject to audit.

On the income side, the results continue to be very positive much like the last few months. As noted in the past, Miscellaneous Revenues continue to be much higher than budget (\$31,321). These continue to reflect rebates from Holy Cross and other miscellaneous items. Fines and Attorney fees and Late Fees are somewhat under budget; the Comcast Franchise Fees continue to drop reflecting the switch from cable to satellite TV. Both Common and Developer Assessments are higher than budgeted amounts. Also, the transfer from the Operating Fund to the Reserve Funds had not been made at year end close. This results in a higher than budget amount in the Operating Fund and lower than budget in the Reserve funds.

On the expense side, the actuals are lower than budgeted amounts (\$16,563) with the Street Light Electricity, Legal Services, Trail Maintenance, and others under budgeted amounts.

Again the Street Light Electricity reflects the change out to LEDs, some \$19,874 under budget. This was a good decision.

Those accounts exceeding budget by significant amounts are Community Relations (The Annual Meeting expense), Bank Charges, and Utility Locates (again a reminder that the Association is now legally responsible for all Utility Locates) and most Maintenance Accounts. The 2016 Revised Budget will reflect this. In spite of these items, the bottom line is very positive by some \$69,466.

On the Balance Sheet, the Accounts Receivable are a little high due to the Developer not paying their December assessment until January 4, 2016. That amount if paid by December 31, 2015 would have decreased the A/R to \$83,577.05.

All in all, it was a good year!

# **Reserve Accounts**

We also reviewed the Reserve Accounts invested with Edward Jones. They continue to earn small amounts but are consistent with the State Laws requiring investing in secure accounts. Some limited amount of funds has been used for approved projects.

The audit by our CPA is scheduled to start the week of Feb. 8, 2016.







Amie, I did not have a committee meeting this month. I have attached information that I have received regarding the Form 2A's and the Form 2's related to the URSA submission to the COGCC.

Kirby Wynn has provided me the information provided by the COGCC:

- The public comment period for Ursa's COGCC applications for the BMC-B and BMC-D well pads and associated wells inside the PUD is now open. The attached files describe how to locate and view the application materials and comment on the Location (Form 2A) permits. Be advised comment period for the public and LGDs (me for example) will close February 16<sup>th</sup>. Based on experience you will want to add any comments by midnight February 15<sup>th</sup>.
- When you look over the applications you may notice COGCC has documented that I have already requested and received the automatic comment period extension that has extended the comment deadline from Jan 26<sup>th</sup> to Feb 16<sup>th</sup>
- Additionally, below I have pasted the direct web link information for the two Form 2A's (BMC B and BMC D pads). You might find that useful to quickly get access to view and download the permit applications and all attachments. Clicking on the little icon right below the heading "Doc" should pop up a window showing links to their application and attachments for each pad. PLEASE NOTE, viewing the documents via the below web links, while handy, does not provide access to provide public comment. Use the attached instructional documents to follow a path that includes posting public comment on the applications.
- You may also review and comment on the individual well permit applications (Form 2) although approval/denial
  of the Form 2A controls whether individual well permits will be granted (Can't have a well without a previously
  approved well pad). Use the same attached instructions, but instead of doing a search of Form 2A's search for
  the Form 2's instead. Here is the web link that provides the most direct access to search for permit applications

- Lastly, at the request of our county commissioners I will start attending the BMSA meetings beginning this month. Steve could I be added to your meeting agenda distribution list and also could I have a brief slot on the agenda this month to speak to my O&G liaison role with the county and to update BMSA on the COGCC application process (and offer assistance to BMSA and your residents regarding oil and gas topics.

<u>Delegate Elections</u>: Main-in elections were held in Monument Creek Village and Tamarisk Village this past week and sufficient ballots were cast to establish the necessary quorum requirements. John Johnson was elected as the new delegate in Monument Creek Village and Eric Short was re-elected as the delegate in Tamarisk Village. Each delegate was elected to a three year term. The Management office is moving forward with a mailin election for Tamarisk Meadows and hope to have a delegate elected in time for the February meeting.

**Battlement Mesa / Parachute Trails Group**: I have been participating with a recently formed group made up of local residents and organization members to expand and enhance the trail systems in the Battlement Mesa and Parachute area. The group has been organized by Mary Lee Mohrlang as part of an economic development strategy as well as a means to provide an improved and valuable amenity for local residents.

The group is in the very early stages and is still working to define the parameters of the tasks they will need to accomplish. Their initial plan is to create an inventory of existing trails as well as work on a master plan for future trails and trail extensions utilizing the work previously done by the BMSA, Trails Committee, in Battlement Mesa. It is there hope to gain support from the BMSA, Town of Parachute, Parachute/Battlement Mesa Parks & Recreation District, Grand Valley Fire Protection District, School District 16 and local businesses and organizations to assist them as they move forward.

Recycle Dumpster: This past year I have received quite a few comments from residents concerning the recycle dumpster being to full to allow them to put their recyclables in it. Usually it is the cardboard section that is over flowing. I spoke with Gerald Cook, of Dependable Waste, last year about the possibility of providing a smaller second dumpster specifically for cardboard. Gerald actually purchased a smaller dumpster that would work for this service but hasn't provided me with a cost to provide the service. Dependable Waste provides the current recycle service at an annual cost of approximately \$13,500. In 2012 the BMSA paid Waste Management \$29,000 to provide this service. Occupancy levels have been increasing in BMP's rentals and I expect the volume of recyclables to increase over the next year. Does the Board of Directors want me to discuss expanding the service with Dependable Waste?
